14. Chair's announcements concerning Coordinators' decisions

1) Adoption of the agenda for 9-10 November and requests for agendas

The agenda for 9-10 November was approved.

The request from ALDE on Petitions 1215/2015 and 1216/2015, on an accident near Santiago de Compostela was postponed to a later date.

The request from GUE-NGL on Petition 2169/2014, on the modification of the protection regime of natural parks in the region of Valence was included in the agenda of 28-29 November.

The request from EFDD on Petition 0254/2013 on behalf of the 'Comitato Popolare SOS C&C', bearing 2350 signatures, on the "Ex C&C' toxic waste discharge (Padua, Italy)", was included in the agenda of 28-29 November.

2) Reports and opinions

The coordinators agreed to do an opinion on three procedures lead by JURI:

- Jurisdiction, recognition and enforcement of decisions in matrimonial matters and the matters of parental responsibility, and on international child abduction (recast) COM(2016)0411.

The opinion was attributed to the S&D group.

- Proposal for a Regulation of the European Parliament and of the Council on the cross-border exchange between the Union and third countries of accessible format copies of certain works and other subject-matter protected by copyright and related rights for the benefit of persons who are blind, visually impaired or otherwise print disabled - COM(2016)595

The opinion was attributed to the Greens/EFA group.

- Proposal for a Directive of the European Parliament and of the Council on certain permitted uses of works and other subject-matter protected by copyright and related rights for the benefit of persons who are blind, visually impaired or otherwise print disabled and amending Directive 2001/29/EC on the harmonisation of certain aspects of copyright and related rights in the information society - COM(2016)596

- a hearing on "Restoring citizens' confidence and trust into the European project".

As regards **delegation visits** (fact-finding visits), they agreed on:

- one to Spain, to investigate the allegations concerning newborn babies stolen from hospitals during and after Franco's dictatorship on the basis of petitions (during the green week of February 2017);

- one to Sweden to investigate the potential infringement on personal registration number (during the green week of May 2017).

7) Fracking - follow-up of the discussion on petitions on fracking in July

Coordinators agreed to do an opinion in case ENVI and/or ITRE decide to adopt an INI report on the basis of the forthcoming Commission communication, expected in November.

Coordinators also agreed to Chair's proposal to adopt a short resolution as follow-up to the hearing on the Obstacles to free movement of citizens, which took place on 11 October.
